Agreement to Participate in Mediation

Introduction

This Agreement to Participate in Mediation ("Agreement") is made under the auspices of Resolute Mediation & Arbitration Inc. ("RM&A"), with the intent to engage in the mediation process to seek a voluntary resolution of the disputes listed herein. The parties acknowledge the benefits of mediation and agree to participate in the mediation process facilitated by RM&A.

Agreement Content

1. Parties to the Agreement: The undersigned parties hereby agree to participate in mediation facilitated by RM&A to resolve the dispute described herein. The parties' full names and contact information are as follows: [_____, _____, _____, _____].

2. Commitment to Mediate: The parties agree to mediate in good faith under the guidance of RM&A to resolve their dispute. The parties recognize that mediation is a process of negotiation facilitated by a neutral third-party mediator provided by RM&A.

3. Role of the Mediator: A mediator from RM&A will act as a neutral facilitator without the power to impose a decision on the parties. The mediator's role is to assist the parties in reaching a voluntary agreement on the terms of their dispute.

4. Confidentiality: All discussions, negotiations, and documents presented during the mediation process are confidential. The parties agree not to disclose any information shared during mediation sessions to any third party, except as required by law.

5. Voluntary Participation: Participation in mediation sessions facilitated by RM&A is voluntary. Any party may withdraw from the mediation process at any time without prejudice.

6. Legal Representation: Parties may choose to be represented by legal counsel during the mediation sessions and are encouraged to seek legal advice before signing any mediated agreement.

7. Mediation Process: The mediation process will include an initial meeting to clarify the issues in dispute, followed by negotiation sessions as necessary. The mediator will facilitate discussions and negotiations but will not make decisions for the parties.

8. Costs: The costs of mediation services provided by RM&A will be shared equally by the parties unless otherwise agreed upon. Detailed arrangements for covering the costs will be provided by RM&A.

9. No Litigation Clause: The parties agree not to initiate or continue any litigation or other formal dispute resolution process regarding the matters in dispute during the mediation process, except to protect legal rights pending resolution.
